## PSYCHOLOGICAL STRESS EVALUATION RELEASE

do hereby voluntarily, without duress, coercion, threats, promises of reward or immunity, agree to an interview procedure utilizing the Dektor PSE-1 for Psychological stress Evaluation. This Interview shall be for the purpose of psychological evaluation of the statements I made to the interviewer.

I have had the procedure explained to me: my conversation with, and statements to the interviewer, will be tape recorded without the use of any sensors attached to my body. Such tape recordings will be chartered in the Dektor PSE-1 Psychological Stress Evaluator and Subjected To Psychological evaluation. This Procedure has been explained to me to my satisfaction and I hereby consent to the interview procedure described.

I do not need to allow any psychological evaluation of my statements, but if I make an incriminating statement, that it may be used against me, I am willing to make my statements to the person below as interviewer, freely without promise of reward and without force, threat or duress being exerted on me. It has been made known to me and I am aware that my refusal to submit to PSE-1 test will result in the disqualification and forfeiture of all prizes and/or awards due me or the Bass Club that I represent. I am aware that I can stop talking or end the interview at any time at any time that I desire to do so. I hereby authorize these persons named below to tape record my statements until such a time as I may decide that I do not wish to continue.

From any and all liability resulting from the interview and the PSE-1 Evaluation for statements made by me and recorded for this evaluation.
